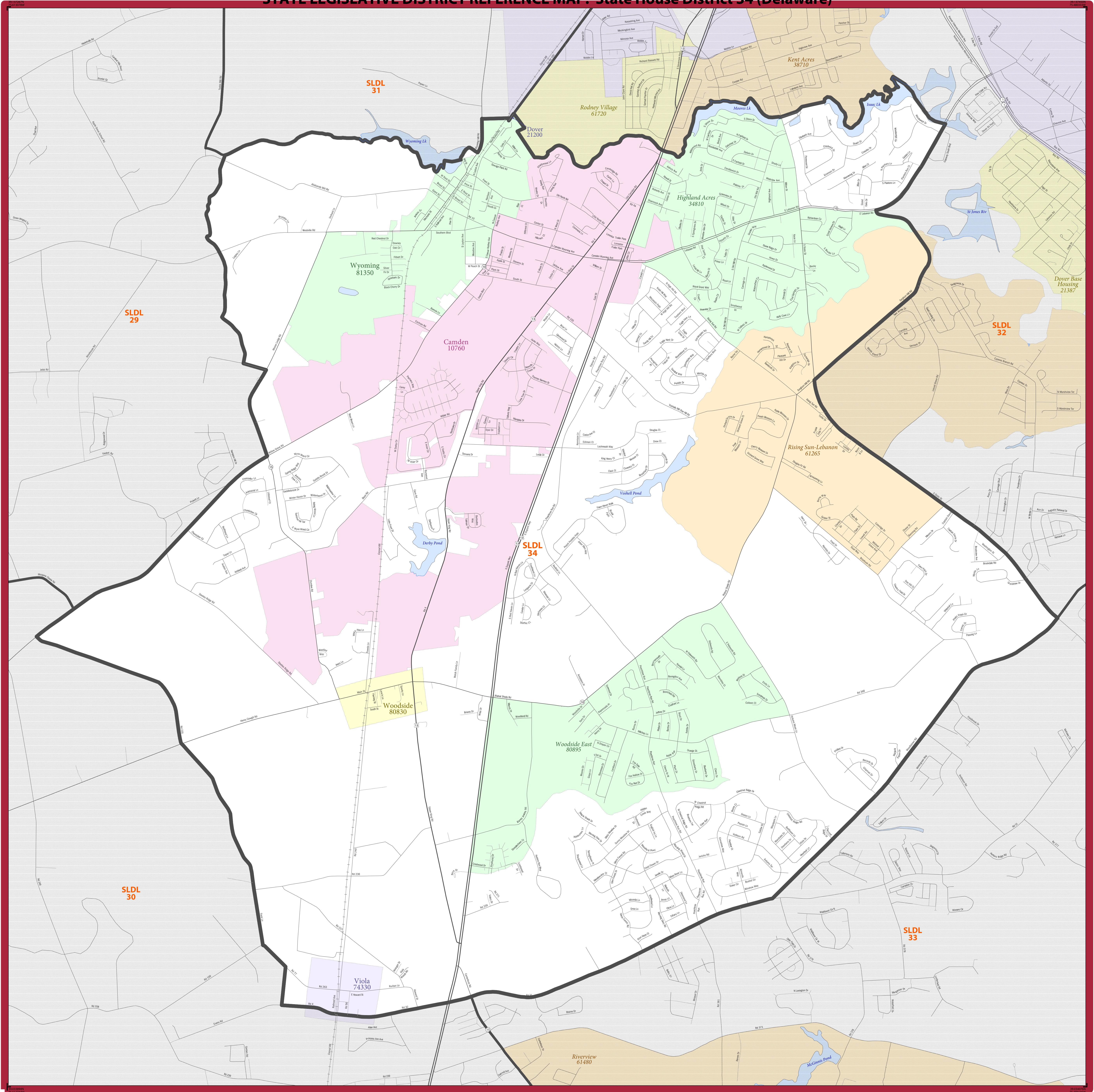


# STATE LEGISLATIVE DISTRICT REFERENCE MAP: State House District 34 (Delaware)
